Bylaw No. 185/1999[B]

BEING A BYLAW OF THE SUMMER VILLAGE OF SILVER BEACH, IN THE PROVINCE OF ALBERTA, UNDER THE FREEDOM OF INFORMATION AND PROTECTION OF PRIVACY ACT

WHEREAS pursuant to section 89 of the *Freedom of Information and Protection of Privacy Act*, Statutes of Alberta 1994, chapter F-18.5, the Summer Village of Silver Beach must designate a person or group of persons as the head of the Summer Village for the purpose of the Act,

WHEREAS pursuant to section 87 and 89 of the *Freedom of Information and Protection of Privacy Act*, the Summer Village of Silver Beach may set fees payable to the Summer Village for services provided under the Act and regulations;

NOW THEREFORE the Council of the Summer Village of Silver Beach, duly assembled, and in accordance with the authority provided to the Municipality enacts as follows:

I. Purpose

1. The purpose of this Bylaw is to establish the administrative structure of the Summer Village of Silver Beach in relation to the *Freedom of Information and Protection of Privacy Act*, and to set fees there under.

II. Designated Head

1. For the purpose of the *Freedom of Information and Protection of Privacy Act*, the Mayor is designated the head of the Summer Village.

III. Fees

Where an applicant is required to pay a fee for services, the fee payable is in accordance with the *Freedom of Information and Protection of Privacy Act Regulation* (AR 200/98).
