Blaine Hill presented suggested changes around the Land Use Bylaw and the Municipal Development plan:

- Mr. Hill said the land had been farmed since 1930's, that he hays the area, and that he would like to have options such as a community garden, flower beds, trail or bee hives. Mr. Hill did note that another County does not have agricultural land less than 20 acres, and this property is 8 acres.
- Proposed the title "conservation" was too much as the whole area is shown as conservation and his intention was only to conserve approximately half of the property.

Notice of issuance of a development permit is to be made to the owners of lots sharing property lines on either side of the parcel for which the development permit is issued and to the lots immediately across the Summer Village of Silver Beach road by:

- (a) mail using the mailing addresses recorded on the Summer Village's tax roll;
- (b) delivering the notice to an owner of each lot; or
- (c) electronic methods of delivery, including by email, using contact information provided by an owner <u>of each lot</u> and on the records of the Summer Village.

A single notice mailed to the tax roll address is deemed to be notice to all registered owners of that lot. The date on which notice of issuance of permit is mailed or delivered is the date of notice for purposes of determining the start of the period to file a valid appeal.

7. Create a new zoning map of the whole Summer Village, which includes the new DC – Direct Control district.
